

**FORT WEBB MANOR PHASE II
RENTAL APPLICATION**

BASIC RENTAL CRITERIA

1. All applicants must be at least fifty-five (55) years of age or older. One bedroom rent is \$555 and two bedroom rent is \$675. There is NO subsidy provided for rent. Security deposit will be one month's rent.
2. Applicants must have verifiable current employment or income. In the event that the applicant has been at his or her current job for a period of six (6) months or less, then the applicant must provide verification of prior employment. Should the applicant be self-employed, he or she must then provide a copy of the previous year's tax return
3. Applicant must have a verifiable rental reference of six (6) months or more with a lease term fulfilled and a copy of the thirty (30) day written notice to vacate current or previous address provided. Applicant must not have more than two (2) late payments and/or non-sufficient fund (NSF) check in one (1) year of residency. Any applicant with questionable rental history or a prior eviction may be subject to denial of application.
4. Applicant credit report must be in good and acceptable standing. Medical collection accounts will be the only exception in determining acceptable credit. Personal bankruptcies shall be allowable as long as the applicant meets all other qualifications and criteria and has re-established a good credit rating.
5. Any and all adults must complete a rental application, be listed on the lease as a resident, and have full liability to fulfill all terms and conditions of the lease.
6. Applicants and household members over the age of 18 must consent to a background and criminal investigation search. Criminal charges and/or convictions may be grounds for denial.
7. Residents will be responsible for all applicable utility costs including, electric, water, sewer, trash, cable, etc.
8. Pets may be permitted upon landlord or management written approval. If approved, there will be a 1 pet per apartment limitation. Application shall be required to provide a pet deposit of \$200 for one (1) pet, of which \$200 per pet shall be non-refundable for repair and/or cleaning purposes after the premises are vacated. Our policy may exclude the approval of some breeds and sizes.
9. Social Security cards, proof of birth, proof of income from all sources for all household members must be provided before the application is considered complete.
10. Completed applications shall be processed in order they are received and qualified applicants will be selected on a first come, first served basis.

11. MAXIMUM OCCUPANCY STANDARDS:

- a. 1 Bedroom has a maximum occupancy of two (2) persons
- b. 2 Bedroom has a maximum occupancy of three (3) persons
